Pursuant to Section 859-a of NYS General Municipal Law, a public hearing will be conducted by the Wyoming County Industrial Development Agency (the "Agency") on May 5, 2021 at 3 p.m. regarding the project, as described below, said public hearing, given the ongoing COVID-19 public health crisis and related Executive Orders issued by Governor Andrew M. Drasgow, Inc. has submitted an application to the Agency (a copy of which is on file at the office of the Agency) requesting that the Agency undertake a certain project (the "Project") consisting of the construction and equipping of a 4,356+/- sq. ft. pole style building addition to its existing manufacturing facility (the "Project"), to be located at 4150 Poplar Tree Road in the Town of Wethersfield which Project will have a total project cost not to exceed \$690,000.

The Agency contemplates that it will provide financial assistance to the Company in the form of: (i) sales and use tax exemption benefits on materials and equipment with a cost not to exceed \$312,500, (ii) mortgage recording tax exemption benefits on an amount not to exceed \$450,000 and (iii) a ten (10) year partial abatement of real property taxes pursuant to the terms of a standard payment-in-lieu-of-tax agreement ("PILOT Agreement").
