Adoption of, or Change in, Accounting Policies Management has the ultimate responsibility for the appropriateness of the accounting policies used by the Loan Corporation. In the current year the Loan Corporation implemented the provisions of Governmental Accounting Standards Board (GASB) Statement No. 85, <i>Omnibus 2017</i> . Significant or Unusual Transactions We did not identify any significant or unusual transactions or significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus. Management's Judgments and Accounting Estimates Summary information about the process used by management in formulating particularly sensitive accounting estimates and about our conclusions regarding the reasonableness of those estimates is in the attached "Summary of Accounting Estimates."
Basis of Accounting	The financial statements were prepared on assumption that the Loan Corporation will continue as a going concern.
Audit Adjustments	Audit adjustments proposed by us and recorded by the Loan Corporation are shown in the attached "Summary of Recorded Audit Adjustments."
Uncorrected Misstatements	We are not aware of any uncorrected misstatements noted during our audit other than misstatements that are clearly trivial.

 Summary of Significant Accounting Estimates
 Year Ended December 31, 2019**

Accounting estimates are an integral part of the preparation of financial statements and are based upon management's current judgment. The process used by management encompasses their knowledge and experience about past and current events and certain assumptions about future events. You may wish to monitor throughout the year the process used to determine and record these accounting estimates. The following describes the significant accounting estimate reflected in the Loan Corporation's December 31, 2019 financial statements.

Allowance for Uncollectible Notes	Management estimates the collectability of their notes portfolio on a note by note basis based on conditions that exist at the time of the audit.	Management reviews note payment history and correspondence with borrowers in evaluating the allowance for uncollectible notes every year.	Management's process to estimate the allowance for uncollectible notes appears reasonable.

Recently Issued Accounting Standards

The GASB has issued the following statement not yet implemented by the Loan Corporation. The Loan Corporation's management has not yet determined the effect this statement will have on the Loan Corporation's financial statements. However, the Loan Corporation plans to implement the standard by the required date. The Statement which might impact the Loan Corporation is as follows:

Summary of GASB Statement No. 87, *Leases*

This Statement was issued in June 2017 and will be effective for the Center beginning with its fiscal year ending December 31, 2020. The objective of this Statement is to better meet the information needs of financial statement users by improving accounting and financial reporting for leases by governments. This Statement increases the usefulness of governments' financial statements by requiring recognition of certain lease assets and liabilities for leases that previously were classified as operating leases and recognized as inflows of resources or outflows of resources based on the payment provisions of the contract. It establishes a single model for lease accounting based on the foundational principle that leases are financings of the right to use an underlying asset. Under this Statement, a lessee is required to recognize a lease liability and an intangible right-to-use lease asset, and a lessor is required to recognize a lease receivable and a deferred inflow of resources, thereby enhancing the relevance and consistency of information about governments' leasing activities.

The requirements of GASB Statement No. 87 are effective for financial periods beginning after December 15, 2019. Earlier application is encouraged.

Financial Statements


12. We have provided you with:
