

WYOMING COUNTY INDUSTRIAL DEVELOPMENT AGENCY
NOTICE OF PUBLIC HEARING

Pursuant to Section 859-a of NYS General Municipal Law, a public hearing will be conducted by the Wyoming County Industrial Development Agency (the “Agency”) on April 6, 2021 at 2:00 p.m. regarding the project, as described below, said public hearing, given the ongoing COVID-19 public health crisis and related Executive Orders issued by Governor Andrew M. Cuomo, to be conducted electronically as hereinafter described. **Please note the special hearing logistics and instructions included at the end of this Notice.**

Michael Kelly d/b/a Kelly’s Garage has submitted an application to the Agency (a copy of which is on file at the office of the Agency) requesting that the Agency undertake a certain project consisting of the construction and equipping of a 16,000+/- sq. ft. pre-engineered steel building to be utilized for the fabrication and set-up of equipment and as a storage warehouse for fabricated items awaiting distribution and inventory storage for parts, accessories and delivery vehicles (the “Project”). The Project will be located at 2842 Route 246 in the Town of Perry. The total cost of the Project is \$835,000.

The Agency contemplates that it will provide financial assistance to the Company in the form of: (i) sales and use tax exemption benefits in an amount not to exceed \$40,000 (ii) a ten (10) year partial abatement of real property taxes pursuant to the terms of a standard IDA payment-in-lieu-of-tax agreement (“PILOT Agreement”). This schedule will apply to the increased assessed value created by the construction associated with this Project.

PLEASE NOTE SPECIAL PUBLIC HEARING CONDUCT INSTRUCTIONS AND INFORMATION:

In accordance with Section 859-a of the NYS General Municipal Law, a representative of the Agency will present a copy of the Company’s project application, which is also available for viewing on the Agency’s website at www.wycoida.org. However, given the ongoing COVID-19 public health crisis and related Executive Orders issued by Governor Andrew M. Cuomo, the Agency will not be able to accommodate any in-person public attendance or participation at this hearing. Nonetheless, and in furtherance of the provisions of Section 859-a of the NYS General Municipal Law requiring interested parties be provided a reasonable opportunity, both orally and in writing, to present their views with respect to the Project, and pursuant to Governor Cuomo’s Executive Order 202.15 issued on April 9, 2020, as amended from time to time, authorizing the conduct of public hearings through use of telephone conference, video conference and/or other similar service, the Agency will livestream the Public Hearing on its YouTube Channel at <https://www.youtube.com/channel/UCrexugLTuFMeOsJNfttiH-Q>. The Agency will provide public access to provide oral comments during the Public Hearing via Zoom Meetings.
