HEARING**

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Article 18-A of the New York State General Municipal Law will be held by the Wyoming County Industrial Development Agency (WCIDA) on the 18th day of February 2020, at 3 p.m. at The Bennington Town Hall 905 Old Alleghany Road Bennington, New York regarding the following matter:

Duke Energy Renewables Solar, LLC has requested that the WCIDA provide financial assistance for the proposed construction and equipping of a 20+/- megawatt (MW) AC solar photovoltaic electric generating facility comprised of solar panel arrays, electrical substation improvements and associated appurtenances, equipment and improvements (the "Project"), to be located at 1235 Clinton Street in the Town of Bennington, which Project will have a total project cost not to exceed \$23,799,507.00. IDA incentives will include sales tax abatement on construction materials and non-production equipment purchased for incorporation in the Project or use at the Project location having a total cost not to exceed \$6,912,631.00 and real property tax abatement pursuant to a customized, non-standard IDA PILOT agreement, the annual payments under which will be calculated with reference to the per megawatt (MW) AC installed capacity of the Project.

A WCIDA representative will be present at the above-stated time and place to hear and accept oral and written comments from all persons with views regarding the proposed financial assistance to Duke Energy Renewables Solar, LLC.
